

E-participation/E-democracy Survey

August 2011

The Electronic Government 2011 survey was mailed to all city-type governments with a population of 2,500 or greater and to all county governments that have either elected executives or appointed managers. An online option was also provided. The survey response is 28%. The survey is collaboration with Dr. Donald F. Norris, Dr. Christopher Reddick, and ICMA, and the data are proprietary.


- Does your local government have a website?

The following instructions were given to respondents:

For the purposes of this survey, the local government website is the official website. This does not include websites produced by the Chamber of Commerce or other organizations (e.g., tourist bureau, economic development agency, etc.). If your local government DOES NOT HAVE a website, you do not need to complete the rest of the survey. Please return it to ICMA. Electronic participation or electronic democracy is defined as the use of electronic means, principally although not solely through local government web sites and the Internet, to promote and enhance citizen engagement with and participation in governmental activities, programs and decision-making. For purposes of this survey, we will use the term e-participation to refer to both eparticipation and e-democracy.
