

# **ICMA Planning across Generations Survey 2013**

The "Planning Across Generations" Survey was a joint project of USDA, Cornell University, and ICMA. It was conducted in the fall of 2013 and closed in May 2014. Surveys were mailed to 7,948 city-type and county governments. An online option was also available. The survey response rate is 19%, with 1,478 local governments responding.

The summary below shows the percentages that provided answers in response to each individual question. Not all local governments answered each question, so the percentages are not based on all survey respondents. The number reporting (N) is provided for each question.






## Is there opposition to joint programming for different ages?




Is it easier to raise funds (e.g., bonds, taxes) if facilities are for?




Does planning for all ages lead to more business and developer investment in services or facilities for the following groups?






Does your community have a comprehensive plan?












