Management System (RMS)/Jail Management System (JMS)**

A Joint Resolution Between the City of Des Moines and County of Polk authorizing Execution of a Joint Public Service 28E Agreement

WHEREAS, under Chapter 28E of the 2005 Code of Iowa, the Polk County Board of Supervisors, the Des Moines City Council, and the Polk County Conservation Board, as public agencies, may enter into an agreement to cooperate in such a way as to provide joint services and facilities, and to cooperate in other ways to mutual advantage; and

WHEREAS, the Public Works Departments for the City of Des Moines and Polk County, the Park and Recreation Department of the City of Des Moines, and the Polk County Conservation Board have developed a "Joint Public Service Agreement" for the sharing of varying equipment, a copy of which is on file in the City Clerk's Office; and

WHEREAS, the Public Works Departments for the City of Des Moines and Polk County have also developed a Final Report concerning other methods in which the two departments may perform group purchasing of materials, offer extension of prices from common vendors, develop a Request for Proposal for group management and purchasing of AVL/GPS equipment, coordinate 5-year Capital Improvement projects, and participate in the Metro Area Public Works Directors Association.

NOW, THEREFORE, BE IT RESOLVED that the Mayor of the City of Des Moines and the Chairperson of the Polk County Board of Supervisors be authorized and directed to sign such "Joint Public Service Agreement" and the City Clerk is authorized and directed to attest to the Mayor's signature.

BE IT FURTHER RESOLVED that the Polk County Director of Public Works be authorized to process the "Joint Public Service Agreement" and complete the agreement as follows:

- 1) Obtain approval and execution of the agreement by Polk County Conservation Board
- 2) Record agreement with the Polk County Recorder.
- 3) File the agreement with the Secretary of State.
- 4) Return a fully executed and recorded copy of agreement to the City of Des Moines.
- 5) Return a fully executed and recorded copy of agreement to the Polk County Conservation Board.

BE IT FURTHER RESOLVED that the Polk County Board of Supervisors and the Des Moines City Council accept and approve the Final Report of the Public Works City/County Team and authorize the Public Works Directors of Polk County and the City of Des Moines to implement the recommendations within the Report.
